

**UW-Madison Transportation Services**  
**2017-18 Program and Rate Changes Brief**  
**Effective September 1, 2017**

**Parking Rates**

*Afternoon Permits*

Currently: Faculty, staff and students with a valid Wiscard are eligible to purchase an Afternoon permit at the rate of \$258 per permit year. Lot 75 permit is \$300.

Change: Available for purchase at \$266 per permit year. Lot 75 permit is \$310.

*Base Lot Permits*

“Change”: Implementation continues of a multi-year plan to condense parking rate structure from three to two rate levels. Adjustments are reflected in the following base lot permit fee increases:

*Department Service Permits*

Currently: UW-Madison departments are eligible to purchase permits for parking departmental vehicles in different areas on campus to conduct university business. Permits are available at the rate of \$927 per permit year.

Change: Available for purchase at \$955 per permit year.

*Moped and Motorcycle Permits*

Currently: Faculty, staff and students with a valid Wiscard are eligible to purchase a Moped or Motorcycle permit at the rate of \$131 per permit year.

Change: Available for purchase at \$135 per permit year.

*Night Permits*

Currently: Faculty, staff and students with a valid Wiscard are eligible to purchase a Night surface lot permit at the rate of \$125 per permit year. Night garage specific permits cost \$40; a Lot 75 Night permit costs \$50.

Change: Night surface lot permits are available for purchase at \$130 per permit year. Night garage specific permits cost \$45; a Lot 75 Night permit costs \$55.

### *Park and Ride Permits*

Currently: Faculty, staff and students with a valid Wiscard are eligible to purchase a Park and Ride permit at the rate of \$273 per permit year.

Change: Available for purchase at \$281 per permit year.

### *Vendor Permits*

Currently: Commercial businesses or private organizations providing service or conducting official University business may purchase parking on campus at the rate of \$1597 per permit year.

Change: Available for purchase at \$1645 per permit year.

## **Policy Changes**

### *Lot 16 - Hours of Enforcement*

Currently: All vehicles must have a valid permit for the lot between 7 a.m. and 4:30 p.m. Monday through Friday. Weekdays after 4:30 p.m. and all day Saturday and Sunday, any vehicle may park in non-reserved stalls.

Change: All vehicles must have a valid permit for the lot between 7 a.m. and 4:30 p.m. Monday through Friday. Weekdays after 4:30 p.m. and all day Saturday and Sunday, any valid UW permit may be used to park in non-reserved stalls.

### *Moped Permit Hours of Control*

Currently: All mopeds must have a valid permit for their assigned lot and park in moped stalls between 7 a.m. and 4:30 p.m.

Change: All mopeds must have a valid permit for their assigned lot and park in moped stalls between 7 a.m. and 4:30 p.m. Residence hall moped lots will be enforced weekdays 7 a.m. to 11 p.m. in order to secure parking for residents who return home later in the day.

## **Product Rates**

### *Employee Bus Pass*

Currently: Employees paid through UW-Madison payroll—including faculty, academic staff, classified employees, limited term employees and emeriti—are eligible to purchase a Madison Metro bus pass for \$24 per permit year.

Change: Available for purchase at \$36 per permit year.

### *Lost/Stolen Bus Pass Replacement Fee*

Currently: Bus pass holders who lose or have their pass stolen must report the loss and pay a \$20 replacement fee.

Change: Replacement fee at \$25 per occurrence.

### *Lost/Stolen Permit or Bicycle Locker/Cage Key Replacement Fee*

Currently: Permit holders or bike locker/cage users who lose or have their permit/key stolen must report the loss and pay a \$65 replacement fee.

Change: Replacement fee at \$70 per occurrence.

### *Lost Ticket Fee*

Currently: Customers who pull a ticket when entering a parking structure and lose their ticket may use the "Lost Ticket" to pay a \$12 fee when exiting.

Change: Fee for "Lost Ticket" is \$20 upon exit.

### *Permit Exchange Fee*

Currently: Permit holders who wish to exchange their assigned permit for a newly received offer must pay a \$20 processing/exchange fee.

Change: Replacement available for \$25 per occurrence.

### *Returned Check Fee*

Currently: If an invalid check payment is made, the administrative processing and return fee is \$20.

Change: Fee is \$25 per occurrence.
