2. Transportation Services Reports & Updates

- **Assistant Vice Chancellor Updates: Patrick Kass, Assistant Vice Chancellor**
 - **Presentation: Salary Based Permit Analysis**
 - **Reviewed Salary Based Permit Analysis presentation to determine whether to keep current system in place or replace the current system with one of the four pricing models presented to the committee during the October 20th presentation.**
 - Banded | Equal Distribution
 - Banded | Set Tiers
 - Percent of Salary (\$3K cap)
 - Non-subsidized reduced cost
 - The current model is a two-tiered rate structure based on location and demand & supports reduced cost permits subsidized UW-Madison & UW Health for \$1.2 million per year.
 - Discussion included (not limited too)
 - Review of the options
 - Consideration of administrative costs implementing salary-based permits
 - How do you determine salaries as they can change during the year, especially for University Staff. Look at a 3-year average?
 - Salary data constantly changes
 - Equity of parking assignments i.e. (I pay more than I should have premier parking.)
 - Salary based parking may hinder recruitment and retention of Faculty and the University is already struggling with this issue. UW Faculty is already underpaid compared to its peers.
 - Recommended that all shared governance groups weigh in. (University Committee, Central Committee, ASEC)
 - The group has mixed ideas as determined by a straw poll.

- Resulting in the following as summarized by Carey McAndrews, Chair...
 - We lean toward stability and predictability both for Transportation Services and Consumers.
 - We have a majority that are open to and even favor progressive pricing. But there is a strong minority that don't favor this.
 - We would like to continue the conversation and see additional study of the topic.
 - We have general consensus that parking needs to be priced and we value the investment in all forms of access to campus. i.e. (Options that do not place more demand on scarce parking.)
- Committee members are to be prepared to discuss a recommendation at the next meeting to be passed along to Campus Leadership.
